SCOPE OF VALIDITY

ARRIVA autobusy a.s., with its registered office at Na Ostrově 177, Chrudim III, 537 01 Chrudim, Company ID No.: 25945408, VAT ID No.: CZ699001947, registered in the Commercial Register maintained by the Regional Court in Hradec Králové, Section B, Insert 2136, e-mail: info@arriva.cz, tel.: +420 725 100 725 (hereinafter referred to as the "Carrier"), hereby issues this Fare Schedule for public domestic scheduled road passenger transport in accordance with the specified conditions laid down by the applicable pricing decree of the Ministry of Finance (hereinafter referred to as the "Fare Schedule").

The prices stated in Czech crowns (CZK) include the reduced VAT rate unless expressly stated otherwise.

This Fare Schedule is valid for the Arriva Express route 721341 Brno – Prostějov – Olomouc.

TYPES OF FARES

The full (ordinary) fare is the price for the transport of a passenger who does not claim entitlement to a discount.

The discounted fare is the price for the transport of a passenger entitled to a discount under the specified conditions laid down by the applicable pricing decree of the Ministry of Finance.

The Carrier reserves the right to set different prices for tickets purchased in advance and for tickets purchased upon boarding the bus

DISCOUNTED FARE FOR CHILDREN AGED 6 TO 18

Children aged 6 to 18 years (i.e. until the day preceding their 18th birthday) shall be transported at a discounted fare amounting to 50% of the full (ordinary) fare applied by the Carrier.

Children aged 6 to 15 are not required to prove entitlement to the fare discount. Children aged 15 to 18 must prove entitlement to the discount by means of an officially issued valid identification document containing a photograph or digital image, full name, and date of birth (identity card or passport).

Entitlement may also be proven by a pupil or student card or a valid ISIC student card.

Pupil or student cards mutually recognised by carriers must contain the pupil's full name, date of birth, current photograph, stamp bearing the carrier's name, and the signature of an authorised employee.

DISCOUNTED FARE FOR STUDENTS AGED 18 TO 26

Pupils and students aged 18 to 26 years (i.e. until the day preceding their 26th birthday) shall be transported at a discounted fare amounting to 50% of the full (ordinary) fare applied by the Carrier.

Entitlement to transportation at the discounted fare applies to students of all schools aged 18 to 26 who are fulfilling compulsory school attendance or continuously preparing for a future profession at a secondary school, higher vocational school, university, or special school in full-time or attendance form of study.

Entitlement to the discounted fare must be proven by a pupil or student card or a valid ISIC student card.

Pupil or student cards mutually recognised by carriers must contain the student's full name, date of birth, current photograph, school name, school stamp, indication of the card's validity period (i.e. school or academic year), stamp bearing the carrier's name, and the signature of an authorised employee.

DISCOUNTED FARE FOR PARENTS VISITING DISABLED CHILDREN PLACED IN INSTITUTIONS

Parents or court-appointed guardians (hereinafter referred to as the "Parents") travelling to visit disabled children placed in institutions shall be transported at a discounted fare amounting to 50% of the full (ordinary) fare applied by the Carrier.

Entitlement to transportation at the discounted fare applies to Parents travelling to visit a child with physical, mental, sensory disabilities or chronic illness who is permanently or long-term (longer than 3 months) placed in an institution or school under the authority of the Ministry of Education, Ministry of Health, or Ministry of Labour and Social Affairs (hereinafter referred to as the "Institution").

Parents are entitled to the discounted fare when travelling from their place of residence to the Institution and back to the original boarding stop, using the shortest or most time-efficient route.

The entitlement to the discounted fare also arises where the child being visited travels together with the Parents.

Entitlement to the discounted fare must be proven by a certificate issued and confirmed by the Institution in which the child is placed.

If the holder of the certificate fails to prove their identity to the Carrier's employees by means of an identity document, the certificate shall be deemed invalid.

If both Parents visit the child, each Parent must possess their own certificate.

The certificate holder shall be checked in at the discounted fare when travelling to the Institution; when travelling from the Institution, only on condition that the visit has been confirmed on the certificate by the Institution with the date, signature, and stamp. The return journey must commence no later than the day following the visit.

DISCOUNTED FARE FOR HOLDERS OF ZTP AND ZTP/P CARDS

Holders of ZTP and ZTP/P disability cards shall be transported at a discounted fare amounting to 25% of the full (ordinary) fare applied by the Carrier.

Entitlement to the discounted fare must be proven by a ZTP or ZTP/P card.

A holder of a ZTP/P card is entitled to free transport for an accompanying person. If a visually impaired holder of a ZTP/P card is accompanied not by a person but by a guide dog, the dog shall be transported free of charge.

DISCOUNTED FARE FOR PASSENGERS OVER 65 YEARS OF AGE

Passengers aged 65 and over shall be transported at a discounted fare amounting to 50% of the full (ordinary) fare applied by the Carrier.

Entitlement to the discounted fare must be proven by an officially issued valid identification document containing a photograph or digital image, full name, and date of birth.

DISCOUNTED FARE FOR PERSONS WITH THIRD-DEGREE DISABILITY

Passengers who have been granted third-degree disability status pursuant to Act No. 155/1995 Coll., on Pension Insurance, as amended, shall be transported at a discounted fare amounting to 50% of the full (ordinary) fare applied by the Carrier.

Entitlement to the discounted fare must be proven by a Confirmation for Fare Discount for Persons with Third-Degree Disability issued by the Czech Social Security Administration (in paper or electronic form), together with an officially issued valid identification document containing a photograph or digital image, full name, and date of birth of the passenger.

FREE TRANSPORT

Children under 6 years of age shall be transported free of charge.

An accompanying person of a holder of a ZTP/P card, guide dogs, assistance dogs, and service dogs of security forces, armed forces, military intelligence, and municipal police officers performing official duties shall also be transported free of charge.

TRANSPORT CHARGES AND LUGGAGE FEES

The transport of live animals is not permitted on route 721341 Brno – Prostějov – Olomouc. Exceptions apply to guide dogs accompanying visually impaired persons, assistance dogs, and service dogs; such dogs may neither be excluded from carriage nor refused transport. These dogs are not required to wear a muzzle.

Hand luggage, accompanying luggage, and checked luggage are transported free of charge on route 721341 Brno – Prostějov – Olomouc.

The conditions for the transport of luggage are governed by the Contractual Conditions of Carriage of ARRIVA autobusy a.s. for regular passenger transport by buses on route 721341 Brno – Prostějov – Olomouc.

SEAT RESERVATIONS

On route 721341 Brno – Prostějov – Olomouc, passengers are required on all services to possess a ticket with a seat reservation. The reservation fee is included in the fare price.

FARE PRICE LIST

The fare price list for route 721341 Brno – Prostějov – Olomouc forms a separate annex to this Fare Schedule.

The prices stated in the Price List for the calculation of full regulated fares include value added tax.

At ticket offices, in the e-shop, or through the Carrier's contractual partners, tickets may be offered at discounted prices published by the relevant seller at the moment of sale. Ticket prices offered in the ARRIVA e-shop may differ for unregistered users (without registration) and registered users (with registration).

FINAL PROVISIONS

The Carrier may cancel, amend, or supplement the wording of this Fare Schedule. Amendments become effective upon publication at www.arriva.cz.

This Fare Schedule becomes effective on 21 October 2025.
