SCOPE OF VALIDITY

ARRIVA CITY a.s., with its registered office at Železničářů 885, Kladno – Kročehlavy, 272 01, Company ID No.: 27229131, VAT ID No.: CZ699001947, registered in the Commercial Register maintained by the Municipal Court in Prague, Section B, Insert 9860, e-mail: info@arriva.cz, tel.: +420 725 100 725 (hereinafter referred to as the "Carrier"), hereby issues this Tariff for public domestic scheduled road passenger transport in accordance with the specified conditions laid down by the valid price regulation issued by the Ministry of Finance (hereinafter referred to as the "Tariff").

The prices stated in Czech crowns (CZK) include the reduced VAT rate unless expressly stated otherwise.

This Tariff is valid for Arriva Express routes 580916 Teplice – Prague and 157710 Prague – Most – Chomutov – Litvínov.

TYPES OF FARES

The Full (Standard) Fare is the price for the transport of a passenger who does not claim entitlement to a discount.

The Reduced Fare is the price for the transport of a passenger entitled to a discount under the specified conditions laid down by the valid price regulation issued by the Ministry of Finance.

The Carrier reserves the right to announce different prices for tickets purchased in advance and for tickets purchased upon boarding the bus.

REDUCED FARE FOR CHILDREN AGED 6 TO 18

Children aged 6 to 18 years (i.e. until the day preceding their 18th birthday) shall be transported at a reduced fare amounting to 50% of the full (standard) fare applied by the Carrier.

Children aged 6 to 15 years are not required to prove entitlement to the fare discount. Children aged 15 to 18 years must prove entitlement to the discount by means of an officially issued valid identification document containing a photograph or digital image, first name and surname, and date of birth (identity card, passport). Entitlement may also be proven by a pupil/student card or a valid ISIC student card.

The pupil/student card mutually recognised by carriers must contain the pupil's first name and surname, date of birth, current photograph, stamp bearing the carrier's name, and the signature of an authorised employee.

REDUCED FARE FOR STUDENTS AGED 18 TO 26

Pupils and students aged 18 to 26 years (i.e. until the day preceding their 26th birthday) shall be transported at a reduced fare amounting to 50% of the full (standard) fare applied by the Carrier.

Entitlement to transportation at a reduced fare applies to students of all schools aged 18 to 26 years who fulfil compulsory school attendance or continuously prepare for a future profession at a secondary school, higher vocational school, university, or special school in full-time or attendance study programmes.

Entitlement to transportation at a reduced fare shall be proven by a pupil/student card or a valid ISIC student card.

The pupil/student card mutually recognised by carriers must contain the pupil's first name and surname, date of birth, current photograph, name of the school, school stamp, indication of the validity period of the card (i.e. school or academic year), stamp bearing the carrier's name, and the signature of an authorised employee.

REDUCED FARE FOR PARENTS VISITING DISABLED CHILDREN PLACED IN INSTITUTIONS

Parents or court-appointed guardians (hereinafter referred to as "Parents") travelling to visit disabled children placed in institutions shall be transported at a reduced fare amounting to 50% of the full (standard) fare applied by the Carrier.

Entitlement to transportation at a reduced fare applies to parents travelling to visit a child with physical, mental, sensory disabilities or chronic illness who is permanently or long-term (more than 3 months) placed in a facility or school under the authority of the Ministry of Education, Ministry of Health, or Ministry of Labour and Social Affairs (hereinafter referred to as the "Institution").

Parents are entitled to transportation at a reduced fare from their place of residence to the Institution and back to the original boarding stop by the shortest or most time-efficient route.

Entitlement to transportation at a reduced fare also arises where the child whose visit entitles the reduced fare accompanies the parents.

Entitlement to transportation at a reduced fare shall be proven by a card issued and certified by the Institution where the child is placed.

If the holder of the card fails to prove their identity to the Carrier's staff by means of an identity document, the card shall be deemed invalid.

If both parents visit the child, each must possess their own card.

The card holder shall be checked in at the reduced fare when travelling to the Institution; when travelling from the Institution only provided that the visit has been confirmed on the card by the date, signature, and stamp of the Institution. The return journey must commence no later than the day following the visit.

REDUCED FARE FOR HOLDERS OF ZTP AND ZTP/P CARDS

Holders of ZTP and ZTP/P disability cards shall be transported at a reduced fare amounting to 25% of the full (standard) fare applied by the Carrier.

Entitlement to the reduced fare shall be proven by a ZTP or ZTP/P card. A holder of a ZTP/P card is entitled to free transport of an accompanying person.

Where a blind holder of a ZTP/P card is accompanied not by a person but by a guide dog, such dog shall be transported free of charge.

REDUCED FARE FOR PASSENGERS OVER 65 YEARS OF AGE

Passengers who have reached the age of 65 years shall be transported at a reduced fare amounting to 50% of the full (standard) fare applied by the Carrier.

Entitlement to the reduced fare shall be proven by an officially issued valid personal identification document containing a photograph or digital image, first name and surname, and date of birth.

REDUCED FARE FOR PERSONS WITH THIRD-DEGREE DISABILITY

Passengers who, within the meaning of Act No. 155/1995 Coll., on Pension Insurance, as amended, have been granted third-degree disability status shall be transported at a reduced fare amounting to 50% of the full (standard) fare applied by the Carrier.

Entitlement to the reduced fare shall be proven by a Confirmation for Fare Discount for Persons with Third-Degree Disability issued by the Czech Social Security Administration (in paper or electronic form) and an officially issued valid personal identification document containing a photograph or digital image, first name and surname, and the passenger's date of birth.

FREE TRANSPORT

Children under 6 years of age shall be transported free of charge.

An accompanying person of a ZTP/P card holder, guide dogs, assistance dogs, and service dogs of security forces, armed forces, military intelligence, and municipal police while performing official duties shall also be transported free of charge.

BAGGAGE AND TRANSPORT CHARGES

The transport of live animals is not permitted on routes 580916 Teplice – Prague and 157710 Prague – Most – Chomutov – Litvínov. Exceptions are guide dogs accompanying blind persons, assistance dogs, and service dogs; such dogs may neither be excluded from transport nor refused transportation. These dogs are not required to wear a muzzle.

Hand luggage, accompanying luggage, and checked luggage are transported free of charge on routes 580916 Teplice – Prague and 157710 Prague – Most – Chomutov – Litvínov. The conditions for luggage transportation are governed by the Contractual Conditions of Transport of ARRIVA CITY a.s. for regular passenger transport by buses on routes 580916 Teplice – Prague and 157710 Prague – Most – Chomutov – Litvínov.

SEAT RESERVATIONS

On routes 580916 Teplice – Prague and 157710 Prague – Most – Chomutov – Litvínov, all services require passengers to hold a ticket with a seat reservation.

The reservation fee is included in the ticket price.

FARE PRICE LIST

The fare price lists for routes 580916 Teplice – Prague and 157710 Prague – Most – Chomutov – Litvínov constitute separate annexes to this Tariff.

The prices stated in the Price List for the calculation of the full regulated fare include value added tax.

At ticket offices, in the e-shop, or through the Carrier's contractual partners, tickets may be offered at discounted prices published by the relevant seller at the time of sale. Ticket prices offered in the ARRIVA e-shop may differ for unregistered users (without registration) and registered users (with registration).

FINAL PROVISIONS
